Trans-Expedite Inc. Becomes ISO 28000:2007 Certified; Expands Offices

Trans-Expedite Inc., a time-sensitive transportation and logistics company, recently became

only the second company in the United States to become ISO 28000:2007 Certified.

ISO 28000 is a security management system for the Supply Chain, and for Trans-Expedite,

it is applicable to warehousing, transportation and distribution services.

According to Keeli Jernigan, CEO and President, "Trans-Expedite Inc.'s Security Management System (SMS) is intended to provide our employees, business partners, customers and other stakeholders with an understanding of our commitment to security. Trans-Expedite Inc. has based the SMS on the company's commitment to continuously evaluate and improve its security management system, including those aspects critical to security assurance of the supply chain, meeting customer and applicable regulatory requirements, and to operate with increased security awareness with the overall aim of enhancing customer trust and satisfaction. "

The company's commitment to security is the foundation of the company's service strategy. The scope of the SMS covers all applicable statutory and regulatory requirements, particularly the Customs Trade Partnership Against Terrorism (CTPAT), the Transportation Security Administration (TSA), Indirect Air Carrier (IAC), Certified Cargo Screening Facility (CCSF), and Foreign Trade Zone (FTZ).

The scope of the company's operations entails the provision of transport, warehousing and distribution utilizing the SMS to monitor and control the security of the supply chain while under company control. This involves working closely with business partners to secure the supply chain upstream and downstream, to strengthen security throughout the global span of the supply chain.

Trans-Expedite has also opened a sixth office, a 60,000 sq. ft. facility located at 100 Jessica Lane in Del Rio, Texas, which includes a bonded warehouse to service the inventory of an automotive parts manufacturer.

Additionally, in January Trans-Expedite moved its 6,000 sq. ft. Dallas office and warehouse space into a 60,000 sq. ft. facility to accommodate expanded customer needs. The DFW office is located at 12880 Valley Branch, Suite 100, Farmers Branch, TX.

Trans-Expedite and its affiliate companies, Trans-Expedite Trucking, LP and TEI Employee Leasing, reached gross sales of \$28M in 2010, the company's largest revenue to date. Projections are expected to exceed \$40M in 2011. The company has also increased its employee base from 70 people to a staff of over 175 at the start of 2011.

Trans-Expedite began operations October 1, 2001, in its Corporate Office located in El Paso, Texas, in a 5,000 square-foot building with only four employees including its founders Keeli Jernigan, CEO and President, and Mark Jernigan, Executive Vice President and COO. The company opened a second operation in San Antonio six years later, and last year opened offices in Grapevine, Texas; Bensenville, Illinois, and Indianapolis, Indiana.

Trans-Expedite is a leader in on-time delivery, and was the first indirect air-carrier to become a Certified Cargo Screening Facility (CCSF) in the El Paso market in response to congress-mandated screening measures that are currently being implemented. Services provided by Trans-Expedite include: next flight out, next day service, second day service, 3-day select service, ground freight, air charter, warehouse management and planning, customs brokerage, and special project consulting.
